#### Dear Brother Knight:

The vision of our founder, the Venerable Michael McGivney, saw "Unity" as an essential virtue in the life of every Brother Knight. Therefore, I am pleased to announce that the Second Degree (Formation Degree) has been revised to strengthen this most important message of "unity of purpose and unity in action." It is also in keeping with my announcement of our initiative, Building the Domestic Church While Strengthening Our Parish. In order to work together effectively it is essential that we be formed as men of faith and that we set an example of unity which strengthens our families and parishes.

To help connect each member to his parish, and to the birthplace of our Order, the Supreme Council will provide each Formation Degree candidate a personal replica of the Carolingian Crucifix, that is small enough to be carried in a pocket, or can be displayed free-standing. The Board of Directors commissioned the Carolingian Crucifix that now adorns the Vatican's St. Cyril and Methodius Chapel, and its replica greets everyone to the sanctuary of St. Mary's Parish, here in New Haven, Connecticut, the birthplace of our Order.

In addition to introducing this personal crucifix, we are honored that our Supreme Chaplain, Archbishop William E. Lori, has authored a new closing prayer for the ceremonial that is entitled "Prayer to the Crucified Christ." Both items, the crucifix and the prayer cards, will be supplied to each Formation Degree staff.

Each state deputy, state ceremonials chairman, and district deputy should take immediate steps to prepare for the smooth transition with current Degree Staff Coordinators, and continue to encourage the formation of additional ceremonial teams to ensure that this relevant message is presented in a most professional and timely manner. Every council should welcome candidates and promote participation in each of the spiritually significant ceremonials of our Order. In all cases, no candidate should have to wait or travel a long distance, in order to attend a degree. The Ceremonials Department will provide additional implementation details in the near future.

This year's theme, **Moved by Mercy**, covers the topics of adoption, post-abortion healing, faithful stewardship of creation, assisted suicide and end-of-life care. The materials include six brochures, a poster, a flyer plus a catalog and a resource guide. All of these materials can be used throughout the fraternal year.

Although the annual number of abortions in the United States is shocking, pro-life efforts are increasingly effective, as abortions have dropped from 1.6 to 1.1 million. A recent Marist/ Knights of Columbus poll found that 45% of those who self-identify as pro-choice, and 62% overall, oppose taxpayer funding of abortion. Moreover, between 2011 and July 2016, state legislatures have passed 334 laws restricting abortion. Through our Ultrasound Initiative, over 700 pregnancy care centers now have ultrasound machines funded by the Knight of Columbus. New pro-life pregnancy care centers keep opening their doors, and a record number of abortion clinics have shut down.

One of the most visible Culture of Life activities is the annual March for Life. Because of the presidential inauguration, the 2017 March for Life is scheduled for Friday, January 27. Every council should consider sending a delegation to Washington, D.C. to participate in this life-affirming march.

# Father Woody's Haven of Hope Newsletter

## **FATHER WOODY'S EMPLOYS THE HOMELESS**

For the past 6 years Father Woody's Haven of Hope has been employing the homeless. We have our homeless friends working in our kitchen, laundry room, front desk and check in area. We do this to not only help them financially, but to help them regain their dignity and put them on a path to self-sufficiency. Over the past 6 years we have had approximately 40 people come and go through our program. Many have moved on to different jobs and some have even decided to go back to school to further their education!

How the program works is simple. We hire most of our workers from people who wanted to volunteer with us to pay us back for what we've done for them. It's a good way to know that they like our mission and are thankful for what we do. Our workers are paid at the end of each week so they have money to either stay in a motel or save it for an apartment that they can eventually move into. We provide them with food, clothing and anything else they need to help make their lives a little better. In the new addition, we will be

installing lockers so they can store their personal items. Most of our contract workers live outside, but they are here every morning at 6:00am ready to work. This has become their home and they know how much we appreciate their help in making Father Woody's one of the best shelters in Denver!

We are the only homeless shelter in Denver that has this program. We've been criticized by some saying we shouldn't intermingle the help with the clients, but I have found it to be that most of our homeless consultants get a sense of pride and fulfillment from helping other homeless men and women. They are extremely hard workers and we treat them just like a part of our staff because thev are. They feel lucky to have a job and we feel blessed to have them.

#### The Battle of Lepanto – 7 October 1571

The Battle of Lepanto was a naval engagement that took place on 7 October 1571 in which a fleet of the Holy League, a coalition of European Catholic maritime states arranged by Pope Pius V, led by Spanish admiral Don Juan of Austria and mostly financed by the Spanish Empire, decisively defeated the fleet of the Ottoman Empire on the northern edge of the Gulf of Corinth, off western Greece. The Ottoman forces sailing westwards from their naval station in Lepanto met the Holy League forces, which came from Messina, Sicily, where they had previously gathered.

The victory of the Holy League prevented the Ottoman Empire from expanding further along the European side of the Mediterranean. Lepanto was the last major naval battle in the Mediterranean fought entirely between galleys and has been assigned great symbolic and historical importance by several historians.

Historically, the engagement was a significant defeat for the Ottomans, who had not lost a major naval battle since the fifteenth century. The defeat was mourned by them as an act of Divine Will, contemporary chronicles recording that "the Imperial Fleet encountered the fleet of the wretched infidels and the will of God turned another way. To half of Christendom, this event encouraged hope for the downfall of "*the Turk*", the Satan-like personification of the Ottoman Empire. Indeed, the Empire lost all but 30 of its ships and as many as 20,000 men, and some Western historians have held it to be the most decisive naval battle anywhere on the globe since the <u>Battle of Actium</u> of 31 BC.

Despite the decisive defeat, the Ottoman Empire rebuilt its navy with a massive effort, by largely imitating the successful Venetian galleasses, in a very short time. By 1572, about six months after the defeat, more than 150 galleys and 8 galleasses, in total 250 ships had been built, including eight of the largest capital ships ever seen in the Mediterranean. With this new fleet the Ottoman Empire was able to reassert its supremacy in the Eastern Mediterranean.

Nevertheless, numerous historians pointed out the historical importance of the battle and how it served as a turning point in history. For instance, it is argued that while the ships were relatively easily replaced, it proved much harder to man them, since so many experienced sailors, oarsmen and soldiers had been lost. The loss of so many of its experienced sailors at Lepanto sapped the fighting effectiveness of the Ottoman navy, a fact emphasized by its avoidance of major confrontations with Christian navies in the years following the battle. Other historians have suggested that the reason for the Turks being contained at the time had less to do with the battle of Lepanto than the fact that they had to contend with a series of wars with Persia, a strong military power at the time.

After 1580, the discouraged Ottomans left the fleet to rot in the waters of the Golden Horn. Especially critical was the loss of most of the caliphate's <u>composite bowmen</u>, which, far beyond ship rams and early firearms, were the Ottomans' main embarked weapon. US historian John F. Guilmartin noted that the losses in this highly specialized class of warrior were irreplaceable in a generation. Paul K. Davis has also stated that: This Turkish defeat stopped Ottomans' expansion into the Mediterranean, thus maintaining western dominance, and confidence grew in the west that Turks, previously unstoppable, could be beaten.

The victory for the Holy League was historically important not only because the Turks lost over 200 ships and 20,000 men killed (not including 12,000 Christian galley slaves who were freed), yet because the victory heralded the end of Turkish supremacy in the Mediterranean.

#### Religious significance

The Holy League credited the victory to the <u>Virgin Mary</u>, whose <u>intercession</u> with God they had implored for victory through the use of the <u>Rosary</u>. Consequently <u>Pope Pius V</u> instituted a new Catholic feast day of Our Lady of Victory to commemorate the battle. And today this feast day is now celebrated by the <u>Catholic Church</u> as the feast of <u>Our Lady of the Rosary</u>.
