 - There is a negative cash flow of (\$1,644.33), the result of recent activity.

 - Confirmation class meets once a month on Sundays from 3-7pm.
 - o The current 2017 Youth Ministry calendar (if a council member would like a copy please email Ms. Shaw at ymdirector@paxchristi.org).
 - There is need for men to get involved in one or more of the scheduled events such as the monthly Confirmation classes.
 - o In the spirit of quid-pro-quo, Roger Giudici solicited support from Chenele and the Youth Ministry to help as servers for the planned 25th Council Anniversary dinner in July.
 - o Gary also invited Chenele to attend one of our monthly planning meetings.
 - o Alan reiterated the Youth Group's need for help and assistance in making it a viable ministry.

• Being that we are involved in a number of activities that involves children and youths, Dave stressed the ongoing necessity in making sure our child protection certifications are current and up-to-date.

- Per the advocate's report, a Safe Environment training class is scheduled for February 18.

XIII. 4th Degree Report – Dave Petteys

- Due to the scheduled District Deputy meeting, the assembly met on January 7.
- The assembly ushered and brought up the gifts for the January 8, 8:30AM mass.
 - The next one is scheduled for February 5, 8:30AM mass.
 - Father Krol would like the assembly to also get involved with the 10:30AM mass, and would involve just the presentation of the gifts no ushering.
- Rosary event(s).
 - The assembly is sponsor for the "5th Sunday Rosary" event that is held after 5PM mass on Sunday. The next one is scheduled for January 29.
 - In time, the plan is to do the rosary at the 5PM Saturday mass, along with eventual expansion to every weekend.
 - This is in support of Supreme's "Building the Domestic Church" program.
- The assembly proposed to Father Bierbaum the idea of having a memorial mass once a quarter, Roger Giudici has for action.

- Father requested that perspective dates, to include mass intentions, be submitted to him for review and de-confliction of schedules, this is in the process of being done.
