VIII. Chancellor's Update - Ken Balcerzak

- The council's seminarian support program is ongoing.
 - Emails sent to our three seminarians, Tim, Colby, and Will, inviting them to the Thanksgiving Basket Drive assembly day, and our Council Christmas Party
 - Two responded, Tim and Colby. They thanked us for inviting them to the Thanksgiving Basket Day event, yet due to a pressing school schedule they had to pass on their regrets.
- Ken led the council in the prayer for vocations.

IX. Committee Reports – Facilitated by Michael Burkett

• Mike started out by mentioning that committee reports are coming due soon.

a. Membership Report – Roger Giudici

- Three Form 100s were read in and approved.
- There is one Form 100 pending, a Chris Kirkkam.
- Roger will not available next Saturday for the Thanksgiving Basket drive event, and needs someone to go around with Form 100s as part of a recruiting effort.

- Joe Regnery and Roger discussed putting together a 'calling tree' to be used as a tool for soliciting membership help with the November 18 Thanksgiving Basket drive build and distribution event.
- Father Krol is putting together a prayer card for non-active members.
- Reminder that recruiting new members is everyone's business.
- Nothing more to report.

b. Church Director Report – Mike Burkett for Dermot O'Doherty

- Donut Sunday
 - While the schedule is ongoing, 'Donut Sunday' has once again been cancelled.
 - Roger asked why we are cancelling donuts so much. He recommended finding out why by getting in touch with Dermot to see what could be done to enhance the program in order to ensure that we do not have so many cancellations.
 - Mike Burkett said that he would contact Dermot about this.
- There is nothing else to report.

c. Community Report - Ford Fay

- The annual Tootsie Roll drive campaign has been completed.
 - While the activity went well and raised \$2,400, Ford stated that overall it was a bit light, down about \$1000 from last year.
 - Ford identified some problem areas that contributed to it being down from last year. One concerns King Soopers store manager turnover rates, and changing rules. Another concerned not starting sooner to nail down prospective venue dates with each store manager. Next year he plans on starting in January to secure prospective dates.
 - Other recommendations from the floor focused on not having activities scheduled on a business meeting day, nor on Sunday morning. Another centered on contacting Special Olympics and ARC to see if they could provide volunteers to help us at each venue.
- Thanksgiving Basket drive is now underway. Ken Balcerzak is the action officer for this initiative and gave an update:
 - We have raised \$10,655 dollars so far, with another \$700 in pledges.
 - Concerning actual baskets, 76 families have pledged to provide one.
 - Money to-date will cover approximately 400 baskets, a wee bit short of our goal of over 500.
 - If the money does not come in, the council may have to cover the deficit.
 - Build and distribution of baskets will take place on the November 18. Volunteer drivers are needed.
 - Roger Giudici recommended, and those in attendance agreed, that a membership calling tree
 needed to be composed. This vehicle would be used to invite all members of the council to
 participate in next Saturday's Thanksgiving Basket drive assembly and distribution effort. The
 purpose of such being to activate uninvolved members by starting a dialog. While many of those
 on the list are active and plan on attending, there is still a need for more involvement. Roger took
 for action.

d. Council Activity Report - Nereus Lobo/Paul Sciera

- The November council social is scheduled for November 17 at 6:30pm at the Olive Garden.
- Nothing more to report.

e. Family Report - Tony Mancuso

- The First Annual All Saint's celebration and fundraiser was held on November 4 after the 5PM mass.
 - This was done in in lieu of the Trunk-or-Treat.

- Our council helped by providing a lasagna dinner.
- Overall it was big success. The wives group's silent auction netted over \$3000, and enough food donations came in to cover expenses so the council broke even there.
- Email will be going out to the council concerning this year's Christmas Party, which is scheduled for Sunday December 10.
 - Help is needed for setup and cleanup.
 - Brian Murphy has agreed to be Santa,
 - Ron Gerber will do the turkey and Gary Mayfield will do the ham.
 - The Marion Icon will need to be procured from State.
 - Knight of the Year and Family of the Year Awards are to be given out.
 - As part of the party, the council will once again host the 'Keeping Christ in Christmas' poster contest.
 - Council will present Father Krol with a donation check of \$1000
- Additionally, Tony is soliciting suggestions for various family activities.

f. Culture of Life report – Mike McGinnis

- The '40 Days for Life' devotional prayer campaign was completed on November 6. There were 632 lives were saved during the 40 day campaign, so our prayers are having an effect.
- Bishop Sheridan's Respect Life dinner was held on October 27 at the Broadmoor Hotel. The council sponsored a table.
 - Overall the event was a big success.
 - The guest speaker was a Ms. Janet Morana, Executive Director of Priests for Life and the Co-Founder of the Silent No More Awareness Campaign, the world's largest mobilization of women and men who have lost children to abortion.
 - Ms. Morana's talk concerned the noted the damaging effects an abortion has on men, women, and children from a spiritual, mental, emotional, physical, and psychological perspective.
- Mike mentioned that in terms of the Affordable Care Act, there has been a positive legal ruling in favor of the 'Sisters of the Sick.
- Continue to consider praying in front of 'Planned Parenthood.'
- Roger mentioned that there is a Respect Life Committee, and they are planning on putting some literature.

Metro District has requested that the honor guard be present for both the opening and closing ceremonies. Showtime is 6:00pm.
- The assembly has paid for a Mass intention for the 5pm Mass today for our nation's veterans.
- On Sunday, November 12, the assembly is scheduled to usher and take up the gifts at the 8:30 mass (7 members in blue shirts), and take up the gifts at the 10:30 mass (3 members in blue shirts.
- We need several people in regalia to help with the opening ceremonies at the Special Olympics State Bowling Tournament at AMF Belleview Lanes (located on Federal just north of Belleview). Opening ceremonies are at 8:15 am, so please arrive by 8:00.
- On December 16 & 17, we will be doing an honor guard at St. Mark for their Saturday 4:00 pm mass (show time is 3:30) and at Pax Christi for our Sunday 5:00 pm mass (show time is 4:30) to mark the first weekend the Rose vestments purchased for Fr. In addition, Dave covered the circumstances and events that inspired Father McGivney to start the Knights as a fraternal based organization, and based on those events, why being an insurance based member is so important. Subject: Colorado State Knights of Columbus "Pennies From Heaven" Program

To: All Grand Knights, District Deputies and State Officers

This is my annual Pennies From Heaven letter. This program was started 28 years ago as a way to help the State K of C raise funds for the many charity requests it receives. At that time, the State K of C did not have any funds set aside to honor these requests. Since this program commenced the State K of C has also added the Fund Crazr football as a source of charity funds.

This Pennies from Heaven program relies solely on the councils support. This past year (May 2016 to April 2017) the councils contributed over \$11,900 bringing the 27 years total to over \$244,000. The money collected is disbursed out each year and not placed in a savings account. Here is where the money went (\$11,900 less the \$3,000 money from the annual auction of the "Pennies" containers that will be paid at the 2018 State convention). The \$8,900 this year plus the \$1,900 from the 2016 containers paid at the State convention this year attributed to the \$10,800 donations.
