 Business Meeting – March 9, 2019

I. General

- For the March meeting there was scheduled First Degree Ceremony, two candidates.
- As part of that ceremony the Council was called to order at 7:31AM by Acting Grand Knight (GK) Mike Melo and the First Degree Team.
- Opening Prayers were offered by Acting GK Mike Mello as part of the First Degree Ceremony.
- The council recited the Pledge of Allegiance.
- The meeting was then paused for the First Degree ceremony.
- After completion of the First Degree, GK Bill Hensen called the council to order and resumed the regular business meeting.
- The Grand Knight then called for the role-call of officers, the results are as follows (P = Present; A = Absence; E = excused)

- The business meeting minutes for February 2019 were read-in for approval by the GK Bill Hensen. Bill then called for a motion to accept the minutes as read. Jim Egan made a motion to accept, Joe Regnery provided a second. After no further discussion a vote was then taken and last month's minutes were unanimously approved.

II. Applications for Approval – Steve Froseth

- Joe Regnery, Membership Chair, mentioned that there is one new Transfer Form 100s that needed to be read-in and voted on:
 - A Mr. Lee Thomas, transfer from St Thomas More. Joe Regnery read him.
 - In the course of the discussion, however, Joe acknowledged that there are some extenuating circumstances tied to this transfer, stemming from a contentious issue that has emerged at the St Thomas More KOC council. The issue and controversy concerns the dissolution of the KOC Ladies Auxillary there by the GK.
 - Joe then opened the floor for discussion concerning this transfer. Brother Ben Stancati came forward arguing the point that since it has been stated that there are circumstances and issues of concern surrounding the transfer that he, in good conscience, would have to vote in the negative on this action.
 - Trustee Paul Sciera asked if his wife anticipated starting a Lady' Auxillary here, and Joe answered no. She plans on participating with our Lady Knight's group. Paul noted that our council some years ago looked at starting a Lady's Auxillary and decided against it, opting instead for a more informal group that would help the council. Paul further noted that a Lady's Auxillary is neither indorsed nor recognized by Supreme and that could be the problem and why the GK at St Thomas More decided to take this action.

- As the discussion progressed it also became clear that the facts surrounding the situation at St. Thomas More are not completely known to our council at this time.
- Additionally, Joe Musso and Gary Mayfield argued the point that fellow Knights with an active membership card do transfer from one council to the next for various reasons, and can attend meetings of other councils.
- GK Bill Hensen then called for a motion to accept. Dick Neuhalfen provided the motion, Mike Melo the second. A vote was then taken and the motion passed.

III. Grand Knight Report – William Hensen

- Events/activities/general information:
 - In order to provide for more functionality and exposure of the KOC product, Homar Alvarado is currently working on making our Council’s web site a subset of the Pax Christi Parish web page. The goal and purpose of this effort is threefold:
 - Communicate our mission and promote our efforts with the Parish
 - Let the Parish know our efforts to give back to others in need
 - Develop a place for Men of like minds to be among the same guys.
 - 2019 Dues are now being collected for all members. As of the meeting, there are currently 46 members that have yet to pay. A second notice letter has been mailed out by the Financial Secretary, please send or bring your payment to an officer as soon as possible. Contact either the GK or Steve Froseth, if you have not received your dues notice
 - State Convention is scheduled for 26 – 28 April, delegates are needed.
 - Child Safe Environment training is being offered at the Parish: Please note that this training is mandatory for all Knights who help at Parish events involving Family and any youth participation. The next adult sessions, both foundational and update, are scheduled for April 8 & 22, and May 6 & 20. Informational flyers are located in the Great Hall along with a notice in the church bulletin. Please make a concerted effort to get signed up.
 - Fish Taco’s are coming in Lent (March- April) on every other Friday after Stations of the Cross, dates to be 3/8, 3/22 and 4/5/2019.
 - In lieu of charging admission or soliciting donations to this event, participants may elect to bring a canned food item to support our 40 Cans For Lent food drive.
 - Volunteers will be needed on those dates to bake fish and prepare meals that begin after Stations of the Cross.
 - 40 Cans For Lent food drive starts the weekend of 9/10 March, and will continue through Lent. Then after the council meeting on the Saturday 4/13, volunteers will be needed to help collect all the food and take it down to the Denver Rescue Mission.
 - Leonard Martinez had been working with Mandi Lupher, Site Director of the St Katherine Drexel school, concerning a golf tournament fundraiser. Based on input from both Leonard and the council membership, it was decided that the council will not be actively involved in this event. Nevertheless, the council will, however, provide whatever support the tourney organizers may need to make it a success. Bill had a meeting with Mandi to let her know our decision. The event is scheduled for July 11.

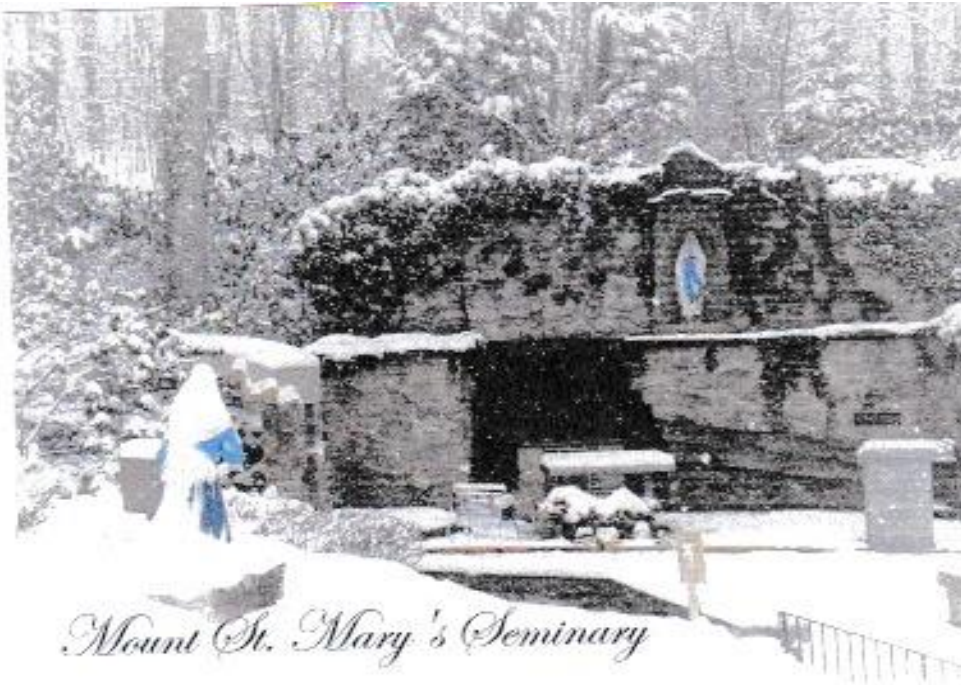
