Let the celebrations continue! Let us celebrate the beatification of Blessed Michael McGivney throughout the year. We celebrated a Thanksgiving Mass for our founder's beatification with Archbishop Aquila at the end of January in Northglenn. The readings spoke of faith and love and the Archbishop eloquently tied those virtues to the attributes of Father McGivney's life.

How fitting an entry into February, a month with national holidays set aside to commemorate presidents and a saint. Men who exemplified faith and love for God, country and fellow man. And, we also begin Lent, an even greater story of faith and love.

In the reading from Hebrews at the Thanksgiving Mass, we heard "... faith is the assurance of things hoped for, the conviction of things not seen." Certainly, Father McGivney had faith and conviction in his vision of an organization to bring men back into the Church. And he must have had faith that the men he chose to share his vision would likewise have faith and conviction to make his vision a reality. Those men did share in Father McGivney's faith and conviction that the founding principles of unity and charity would bring men back into the Church and provide for families when members died.

George Washington had great faith and conviction in the ideal of a country free from the English King and the conviction of his fellow patriots to follow through on their vision of inalienable rights and the quest for independence. Abraham Lincoln led the nation through the Civil War, the country's greatest moral, constitutional, and political crisis. He succeeded in preserving the Union and abolishing slavery. He too, had great faith and conviction in the ideals expressed by our country's Founding Fathers and his oft-expressed personal wish that all men everywhere could be free. Saint Valentine was a clergyman in the Roman Empire who ministered to persecuted Christians. He was arrested for evangelizing and brought before the Emperor Claudius II. When he tried to convince the Emperor to embrace Christianity, he was condemned to death. When given the choice to either renounce his faith or be beaten and beheaded, he stayed strong in his faith and conviction to his beliefs and was executed on February 14, 269.

Lent begins on February 17th and for six weeks we engage in self-examination and reflection. Some of us give up something like candy or meat, while others of us take on a Lenten discipline like bible reading and more prayer. Our goal is to strengthen our faith and draw closer to God. Hopefully we find during Lent that our faith is not just a feel-good, self-help religion but one that answers our deepest questions of life and eternity. An important element of the Lenten season is becoming aware of not only the suffering and sacrifice of Christ but also to the suffering of others. As Knights of Columbus, we must take up the Cross of Christ and journey the 40 days of Lent fasting and praying and encouraging all to walk the Way of the Cross caring for the downtrodden, exiled, alienated, marginalized, cast out and forgotten. We should be imitators of Christ's behavior during The Agony in the Garden. Like him we struggle to understand the demands placed on our lives and like him we should respond with faith, conviction and love - a Heroic Love.

What is Heroic Love? It is the sacrificial, courageous, and brave love that places another's before oneself and seeks the best for that person's life. Heroic Love is our choosing in the midst of the Pandemic to Leave No Neighbor Behind, and seeing the work of the Order as essential work and, having taken every precaution for ourselves and the public, working closely to render services that lead to the saving of lives and souls. It is having the strength of faith and conviction to advance that for which we hope but cannot see, the building of the Kingdom of God on Earth. Through our temporal and spiritual works of mercy and charity, united in a fraternal brother-hood, we possess and must promote good will and glad tidings in our communities.

By emulating the faith and conviction of Father McGivney, George Washington, Abraham Lincoln, St. Valentine and Our Lord Jesus Christ; trusting that the strength of a unified, charitable fraternal brotherhood can make a difference in the lives of men and families throughout the world and especially in our own communities; how can we not share the benefits of membership with every Catholic man we encounter? Is it not our duty to be charitable? And is not charity the welcoming of a stranger as a brother?

A Note from Colorado Knights of Columbus Charities Fund, Inc.

Last month I introduced you to the Colorado Knights of Columbus Charities fund, Inc. To remind you - I presented information about the People with Intellectual Disabilities Annual Campaign, Father McGivney Fund, Football Sweepstakes, Relief Fund and Ultrasound Initiative.

I also introduced you to the newly established Human Trafficking Survivors Recovery Fund, about which I had written to your councils in late October 2020. In that letter I asked you to consider making a donation specifically to help start that fund. These funds will be used to assist organizations which provide services to survivors of trafficking. The funds raised will help to enable organizations assist their clients to transition from human trafficking to self-sufficiency and successful reintegration into society. These funds will help provide a way out for the victims and a way back for survivors.

I also asked you to consider, as part of your council budget, a yearly contribution to the Charities Fund in general.

This month I will present the remaining funds which are part of your State Charities Fund. I do this because I believe that after you know the full scope of what your charities fund supports, you may be more favorably disposed to making donations to support specific funds or the state charities fund in general. Again, when you make a donation, you may designate how you want the amount allocated.

Pennies from Heaven

The "Pennies from Heaven Program" was begun for the purpose of generating funds to be used for charitable contributions identified by the State Council.

Perpetual Memorial Society

The Colorado State Council has developed a "Perpetual Memorial Society" for the intentions of the members of the society. Membership is obtained through a donation of \$50 or more in the name of the proposed member with the intention of membership in the "Perpetual Memorial Society." Proceeds from the membership fees will form an endowment that is held by the Colorado Knights of Columbus Charities Fund, Inc.

The interest from the endowment is to be used:

- 1) To ensure that at least 100 masses are said annually for the members of the society;
- 2) For expenses associated with the maintenance of the Perpetual Memorial Plaque and all administrative expenses of the Society,
- 3) For various charitable purposes as approved by the Elected State Officers of the Colorado State Council.

Global Wheelchair Fund

The Knights of Columbus and the Global Wheelchair Mission have teamed up to help bring wheelchairs to those who lack the freedom of mobility. The Global Wheelchair Mission purchases wheelchairs in bulk and delivers them by sea containers around the world. For every donation of \$150 received, the Global Wheelchair Mission can deliver a brand-new wheelchair. They are shipped in containers of 100 to 280 wheelchairs directly from the factory to the destination at no cost to the recipients. We encourage councils, assemblies, circles and personal contributions directed toward this worthwhile program. Pooling these contributions at the state level allows us to acquire more wheelchairs than a single council can afford and also allows for quicker response to the need for wheelchairs when identified.

Colorado Diocesan Capital Restoration Fund

This fund receives and disburses monies that are received for the restoration of Catholic properties within the State of Colorado. Each restoration funding program is to be at the request and approval of the Bishop of that diocese and will require specific guidelines for donations and disbursements approved by the Bishop and a two-thirds positive vote of the Elected State Officers and the Immediate Past State Deputy. An accounting of -monies allocated to each diocese will be maintained, and only funds allocated to a specific diocese will be spent within that diocese. The status of each project and/or funds available shall be given to each Bishop at the annual meeting of this Corporation and is included in the proceedings of the Colorado State Council.

Christopher Matching Fund Program

In the 1970's, the then current State Council Officers and Past State Deputies decided to create an endowment fund that would utilize only the earnings for charitable purposes with the principal being the impetus to provide those earnings. In 1994, this decision led to the Colorado State Council opting to participate in the Supreme Council's Christopher Matching Fund Program as was adopted by resolution No. 34 at the 1992 Supreme Council meeting.

Included in the Christopher Fund are all substantial donations to the Charities Fund that had been given for the intended purpose of the development of an endowment fund.

Desiring to be able to provide an avenue for councils who may find themselves with a sudden or accumulated large amount of funds that the councils may wish to secure, a procedure has been put into place to allow subordinate councils to participate in the State Christopher Fund.

The focus of the Colorado Knights of Columbus Charities Fund is to exemplify Blessed Michael J. McGivney's founding principle of charity. Councils and/or individuals may wish to focus funds to that end. Being able to fund increased donations to worthy causes that are many times underfunded by the government or through donations, would benefit all affected if the Knights of Columbus were able to provide additional resources and finances to those worthy causes.

How can you as members expand the reach of the State Charities Fund? First and fastest is to make a personal or council donation by sending a check to the Charities Fund Secretary. The second way is to participate in the statewide Pennies from Heaven and People with Intellectual Disabilities Annual Campaign. A third way is to select The Colorado Knights of Columbus Charities Fund, Inc. as a recipient of donations based on your purchases at King Soopers or Amazon Smile. A fourth way is to participate in a charitable giving matching program with your employer and list the Fund as a recipient. I am sure you know of other ways that the Fund could benefit from something you're already doing. Please consider adding the Fund.

My Brother Sir Knights,

Happy Valentine's Day to all!

We have a Virtual Exemplification coming up on February 13, 2021. It will be broadcast from Holy Cross Catholic Church in Thornton, Colorado starting at 2:15 PM that day with the anti-chamber presentation and then proceed to the Exemplification that begins at 2:30 PM. The Exemplification Team and I have worked out most all the issues with doing a Virtual Exemplification and we will have a dress rehearsal the morning of the Exemplification. So far everything is coming together well. The candidates will view the Exemplification from one of five locations. I have two Former District Masters and our State Deputy Chris Foley attending. Our State Deputy along with District Marshal Bob Knapp will attend in Monument. P.S.D. and F.D.M. Roger Muller along with District Marshal Gary Thomas will attend in Broomfield. F.D.M. Bob Buljung along with Ted Hand Jr. will attend in Northglenn. District Marshal Bill Beno will handle the candidate in the Valley while District Marshal Manuel Gomez will take care of the three candidates in Eagle. These worthy Sir Knights will assist or do the Knighting and ensure the candidates are properly Exemplified.

Candidates in Northglenn are invited to attend the 4 PM Mass at Holy Cross where I will be happy to Knight them after the Mass. Any New Sir Knights unable to attend the 4 PM Mass can be knighted by the presiding District Marshal, Former District Master or State Deputy. There is one candidate that will be knighted at the Assisted Living Facility in Monument. This new Sir Knight turned 103 years old in November 2020 and has been a Knight for over 81 years. He decided he had one more thing to do and that was to become a Fourth Degree Knight.

As long as there are COVID restrictions the Supreme Master is advocating that Brother Knights interested in becoming a Sir Knight be encouraged to participate in the Virtual Exemplifications being held in other States. As of today I am aware of two other states holding Exemplifications'. If you know of Brother Knight who is not able to attend the one we are having on February 13, 2021, but wants to become a Sir Knight I can make arrangements with the New Mexico District Master or Michigan District Master for your Brother Knight to participate in their Exemplification. The requirements are the same. A valid Form 4 properly filled out, read and approved by your Assembly. It just needs to be sent to me so I am aware along with the fee required to take the Exemplification.

Sir Knights please be aware and keep in mind that the veil of secrecy has NOT been withdrawn from the Fourth Degree yet. That means only Sir Knights in Good Standing can attend and observe Exemplifications.

The State Convention is at the end of April. Have you submitted your calendar 2020 reports to the State that your Assembly submitted to Supreme last year? I bet not. If you did, I don't have them. Get those reports in right away please.






